It has been a great year for IVC and we are happy to share our results with you in this Annual Report!

IVC is a great choice for your philanthropy. An investment in IVC leverages the work of our partner agencies to serve those living in poverty.

The investments that you have made in our work through the *Magnify! Campaign* have already yielded results. More Volunteers are in service in agencies across the country, and these men and women of the Corps touched the lives of more than 75,000 people last year.

Our Volunteers are living out Pope Francis' call to serve those struggling with poverty.

They are nursing, mentoring, providing emergency assistance, teaching, helping with job searches, providing shelter. They are providing professional services like accounting, volunteer management, administrative support, and more to leanly-staffed nonprofits. They are the face of Christ to the poor and vulnerable in their communities. And as they reflect on these experiences in the Jesuit tradition, they see God in these experiences and feel sustained in their work.

We have a great horizon in front of us and we are working very hard. We anticipate a 20 percent increase in the number of Ignatian Volunteers as we head into next year. And we have everything in place to continue to strengthen and grow our impact. We have a great staff team, strong regional councils, and a unique, hard-working Board of Directors who really roll up their sleeves to serve.

This is a really exciting time for IVC and we are so grateful that you are part of our community of supporters.

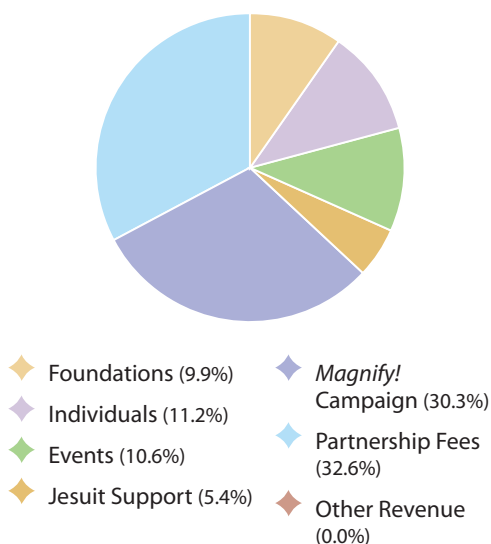

KEY ACCOMPLISHMENTS

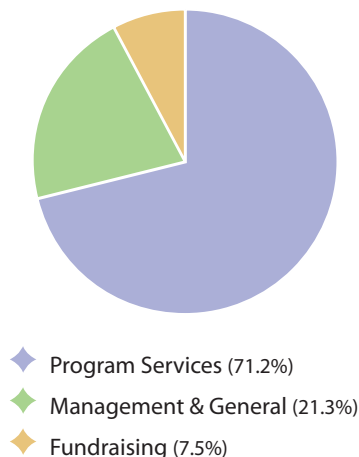
- Major grant support was received from two of the largest Catholic foundations this year, reflecting both their confidence in the leadership of IVC, and their support for the mission of engaging faithful laypeople in service to the poor.
- Strengthening revenues allowed IVC to increase staff capacity in three of our established regions. This, in turn, increased our ability to recruit and place more volunteers into positions with partner agencies.
- IVC placed 392 volunteers in service with partner agencies, a 25% increase versus the prior year.
- Thanks to a foundation grant, we were able to add and fill a Marketing Director position, which will allow IVC to build awareness and attract more volunteers and agency partners.

A Note from the Board Chair



We began the *Magnify!* campaign in 2012 to double the number of Ignatian Volunteers by 2015 and significantly increase our ability to serve our brothers and sisters seeking to overcome poverty. And we're well on the way to achieving that goal. We've grown to 392 volunteers in 2013, in 16 communities around the country.

This growth was made possible by significant increases in revenue brought in by the *Magnify!* Campaign. Total revenues in 2013 grew 32%, to \$1.5 million, allowing us to make important investments in expanding our staff, which has helped us to grow our volunteer numbers, which are up +38% since 2011.

It truly takes a strong team to generate such results, starting with the work of hundreds of Ignatian Volunteers, who give so generously of their time and skills at partner organizations in their communities. Their service is in turn made possible by the excellent staff, spiritual reflectors, regional councils, our Board of Directors, and of course, you, our generous donors.

Your donation to IVC is an investment in the future that is already paying dividends. Thank you very much for your continued support.

and suffering from AIDS and cancer. They often suffer from serious mental illness and are addicted to drugs and alcohol. They are desperately ill, afraid and nearly always – alone.”

Three Ignatian Volunteers serve at Joseph's House in Washington DC, which offers a welcoming community and comprehensive nursing and support services to homeless men and women dying of AIDS and cancer.

“Every year Joseph's House welcomes about 40 people to stay here and be cared for and loved at the end of their lives,” states Executive Director Patty Wudel. “We welcome those who hospitals find hardest to care for – men and women who are homeless

Helen Taney, a nurse, has served since 2005. “Joseph's House cares for people with nowhere to go. Many residents have been rejected by their families... Here, they are never alone. The love and care is transforming to them. Our role is trying to give unconditional love.”

“We help with the tasks of running a home – laundry, cooking, doing dishes. Joseph's House operates through a little army of people: RNs, nurses' aides, volunteers just out of college, Ignatian Volunteers, and staff. Some people get better because they are cared for and loved.”

Kevin Dailey is a retired social worker in his fifth year with IVC. “Patients come from hospitals, their conditions are seen as terminal, and they can't be released to a shelter. Sometimes when they arrive here – it's such an active place, with good meals and care – some patients start to improve. They still have chronic issues, but don't need Joseph's House.”

“I work with them while they're transitioning, to address chronic needs. We work on discharge planning, to link them with substance abuse and mental health programs and with housing. I assist in getting Social Security Disability benefits; help with paperwork, phone calls. It's intense and time consuming, but it's rewarding for me and helpful to Joseph's House.”

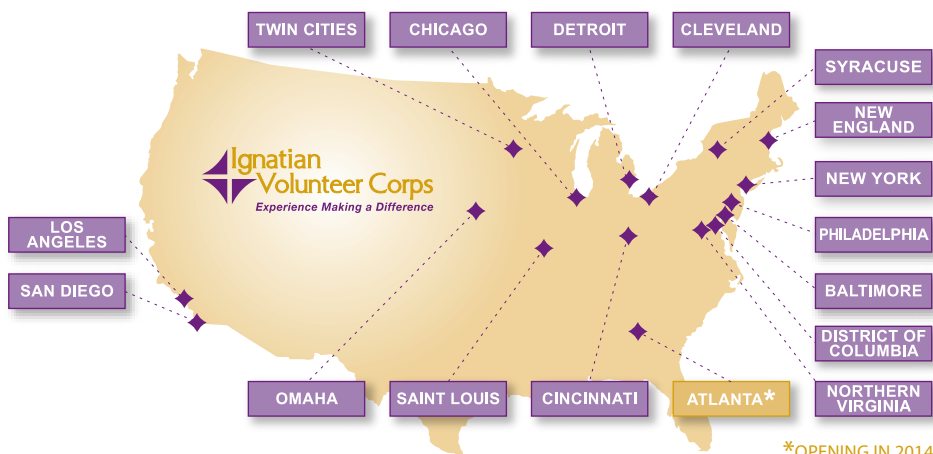
Marie-Claude Terrot, a translator by profession, has been at Joseph's House for 8 years. “I do housekeeping, gardening, and drive residents to appointments. I do whatever there is to do. It's not work. It's a community, almost a family.”

“Joseph's House has a very Ignatian approach, with its depth and the focus on relationships. IVC's Spiritual Support Program is very good – I didn't know it would be that rich when I began.”

“You get way more than you give,” says Marie Claude. “It's not a job. IVC is a great program.”

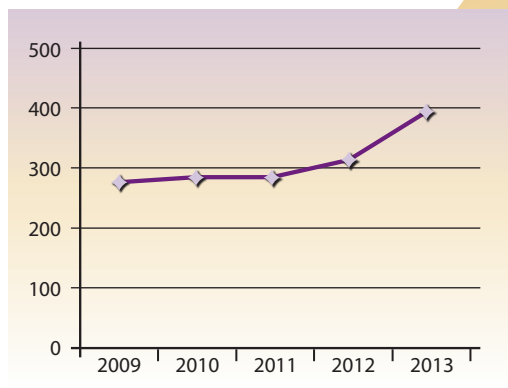
