Bob Barry Goes To Jail!

The obvious advantage/blessing of retirement is the freedom to do what one REALLY would like to do without the economic imperative of a job that comes with a growing family! So, last fall I decided to attend a locally sponsored Citizens' Police Academy. It was a great learning opportunity to better understand the pressures on law enforcement personnel to fight crime while balancing the constitutional rights of the perpetrators and victims; a daily challenge for motivated police personnel. Since the 9- week course impressed me a great deal, I asked: "What's next?"

It turned out to be a spring course at my local community college entitled: Introduction to Criminal Justice. Do you see a pattern here? During this course one learns that there are four different policing "types": Crime Fighter; Law Enforcer; Watchman and Change Agent. Because of my past dealings with social justice issues, I put myself in the Change Agent type. In my concluding course presentation, in fact, I made the case that a life of criminality is very similar to the "circle of poverty" often described as such by the Campaign for Human Development. Hence there is a need for a Change Agent to break the "circle of criminality". At the conclusion of the excellent course again I asked, "What's

Enter Kathleen Groh making a presentation about the Ignatian Volunteer Corps at my parish, St. Thomas Becket in Eagan, MN. Since I had previously volunteered with IVC as a tutor at St. Matthew's School on the west side of St Paul, I asked Kathleen what opportunities were presently available. She was waiting for a job description from the Dakota County Jail in Hastings for a person to assist soon-to-be released inmates by updating the jail's referral data base for employment, education, skills training, parenting, sobriety programs etc. Once again, here was an opportunity to be an Agent of Change. Was this a coincidence or divine intervention? People of faith know the answer!

I am presently going through a multi-week comprehensive orientation program at the jail and have sat through my initial inmate exit interview with a dedicated committee of Change Agents. As a team, we are hoping the circle of criminality can be broken for each individual, each child of God.
